Chiffres de ventes Daimler Truck Q2/2025 : 106,715 unités

- **Ventes unitaires du groupe au deuxième trimestre 2025 : 106 715 unités (deuxième trimestre 2024 : 112 195 unités)**
- **Les ventes unitaires de camions en Amérique du Nord ont diminué par rapport au deuxième trimestre 2024, celles de Mercedes-Benz Trucks sont restées stables, tandis que celles de Trucks Asia et Daimler Buses ont augmenté.**

Leinfelden-Echterdingen – Daimler Truck Group a vendu 106 715 camions et bus (T2 2024 : 112 195) au deuxième trimestre 2025. Le segment Trucks North America a représenté 38 580 unités dans les ventes totales du groupe (T2 2024 : 48 246). Mercedes-Benz Trucks a vendu 38 294 unités (T2 2024 : 38 481). Le segment Trucks Asia a enregistré une augmentation de 13 % de ses ventes, qui ont atteint 26 443 unités (T2 2024 : 23 411). Daimler Buses a augmenté son volume de ventes à 7 027 unités (T2 2024 : 6 674). Au cours du premier semestre, Daimler Truck a vendu 206 527 véhicules (1er semestre 2024 : 221 106 unités).

Ventes unitaires – Selon segment

Au 1er janvier 2025, Daimler Truck a intégré ses activités en Chine et en Inde dans le segment Mercedes-Benz Trucks. La présentation de la comparaison ajustée avec l'année précédente repose sur la nouvelle composition du segment.
