23.06.2023 - The International Trading Group TEMOT International continues to grow: With Multispare, the network has recently won the most important Aftermarket distributor in Australia and New Zealand as new Shareholder. Multispare serves more than 20,000 customers and is growing faster than any other distributor in the domestic market.

Multispare Limited and Multispare NZ Limited are wholly owned subsidiaries of Supply Network Limited, which is listed on the Australian Stock Exchange under the ticker symbol "SNL". Multispare acts as a pure trading company, Supply Network as a holding company.

Multispare looks back on decades of experience: Since its opening in 1976, the company has specialized in spare parts and technological solutions for commercial vehicles weighing four tons and more, in particular buses and trucks from American, European and Japanese makes. The full-line distributor's catalog features approximately 60,000 active part numbers covering one million vehicle applications. The company works with all internationally renowned suppliers in the CV segment.

The new TEMOT Shareholder runs 20 offices in five of Australia's six states, and a further five offices in New Zealand. Currently, it employs around 420 people. Its sales and shipping organization manages 3,600 orders with around 15,000 items per day. An own fleet of 70 delivery vehicles ensures that orders are delivered quickly throughout the country.

The commercial vehicle sector in Australia and New Zealand is characterized by a high and increasing average age of vehicles. There is no evidence of fleet consolidation so far and the increasing complexity of vehicle parts plays into the hands of highly specialized and well-established suppliers like Multispare.
